### The Agreement

I understand that by signing below, I am financially obligated to pay all dues, Food and Beverage Minimums and miscellaneous Member Golf Account Charges/Fees, associated with my yearly membership regardless of any unforeseen circumstances that may occur throughout the Membership year. Any requests for refunds are required to be made to the board of directors in writing and subject to board of director approval at the board's sole discretion.

Monthly billing statements will be sent via email, however, not receiving these statements will not be viewed as grounds for missing a scheduled payment as defined by the schedule below. I understand and agree that if my monthly invoice is not paid in full by the first day of the new billing cycle a 10% non-refundable late fee will be added to my next statement and understand that my account may be suspended, and golfing or restaurant privileges revoked until past due balances are corrected.

I understand that if my Account becomes 45 days past due, my membership and/or food privileges will be revoked from the Club and turned over to an attorney for collections. In the event of collections, I would be responsible for all expenses incurred by the club to include outstanding balance and attorney fees. To be reinstated I must settle all debts and fees.

### **Food and Beverage Billing**

Annual Food and Beverage minimums are in effect from November 2024 through August 2025 (2025-2026 Food minimum subject to change). Minimums will be set at an annual minimum of \$600 for Singles, Intermediate Plus, and Intermediate Membership categories and \$920 for the Family Membership category. No Food and Beverage Minimums are applicable to Junior Plus or Junior Membership Categories.

The Food and Beverage minimum will be split between 2 cycles.

Cycle 1: November 1 – May 31<sup>st</sup>

\$300 for Single, Intermediate, Intermediate Plus and \$460 for Family

Cycle 2: June 1<sup>st</sup> – August 31<sup>st</sup>

\$300 for Single, Intermediate, Intermediate Plus and \$460 for Family

Food and Beverage Minimums are to be used within the corresponding months, (Cycle 1, Nov - May minimum must be entirely used by May 31<sup>st</sup>, Cycle 2, June – August must be entirely used by Aug 31<sup>st</sup>). Applicable Food and Beverage Minimum purchases are any Food and/or Beverage item purchased in the Restaurant, Patio Bar/Restaurant, Pro Shop or Beverage Cart and must be charged to the Member Golf Account to satisfy the Food and Beverage Minimum requirement (ex. Food or Beverage Purchases paid in the form of Cash, Check or Credit Card will not be applied to the Food and Beverage Minimum requirement).

If any and all Food and Beverage Minimums are not satisfied, in full, during the required months, then the unspent balance will be charged to the Member's Golf Account at the end of the period (May 31<sup>st</sup>/August 31<sup>st</sup>).

### **Bag Storage and Locker**

Members will be provided lockers and bag storage, as requested, at the Members risk. Allendale is not liable for any loss or damage to Members personal property for any reason whatsoever. All lockers need to be cleaned out and golf bags need to be removed from ACC property by November 15<sup>th</sup>.

### **Golf Cart Privileges**

Operators of golf carts must be at least 16 years of age and have a valid driver's license. (proof may be required) Golf carts are not to be used by more than two riders and two golf bags at one time. Operators must abide by all directional signs when operating a golf cart. Please make note of the cart path conditions before play. Any damage to any golf cart will be the financial responsibility of the operator and agree to pay for all damages sustained while said cart is in my possession or in the possession of family members or guests.

If applicable, in order to use a handicap flag, a member or guest must have a handicap placard or documentation and remain 30 yards from the greens.

### **Government Directives**

Allendale Country Club will not be held liable for any Government regulations or directives that prohibit Allendale Country Club's ability to provide member services including but not limited to Food, Beverage, Golf, Bag Storage, Range and Facility Access, etc. Allendale Country Club will also not be held responsible for any decisions Allendale makes, at its sole discretion, in the safety interests of its Staff, Members or Guests.

### **Rules Related to Member and Guest Conduct**

Each Member agrees to abide by all rules and regulations established by Management related to conduct. These rules may include, without limitations, rules regarding conduct injurious to the operation of the Club, the reputation of the Club and/or Club Members, non-payment of fees and/or charges in accordance with the Club's terms, dress code, and golf etiquette. All Members and their guests are expected to adhere to proper conduct, including, but not limited to: repairing ball marks and divots on the course; refraining from using abusive language; no harassment of staff members or other Club guests; no violent behavior, such as club-throwing and interpersonal confrontations; compliance with stated cart rules; as well as acting in respectfully and with reasonable care for golf course property and equipment. In addition, any Member choosing to disregard Club hours of business, including, but not limited to the closure of the facility on holidays or rain days, will result in automatic forfeiture of the remaining Membership privileges without negotiation or compensation. Violations of any of the above rules or Club policies may result in the Club's right to cancel or revoke a member's benefits for a specified time or permanently at Management's discretion without negotiation or compensation.
