The Contract

The undersigned further agrees to promptly pay all dues, assessments, and other charges as invoiced by the Club. The BOD reserves the right to suspend or revoke any membership application for any reason at the sole discretion of the BOD.

Billing statements will be sent via email; however, failure to receive a statement does not relieve Members of their payment obligations. Membership dues paid in installments will be billed on the 1st of each month, and Member Golf Account charges (food and beverage, golf shop, and other charges) will be billed on the 15th of each month. A valid credit or debit card must be kept on file for all memberships. If the credit or debit card on file is declined for two consecutive billing cycles, the Member's account and Club privileges will be suspended until the account is brought current.

Accounts 30 days past due may have membership and food and beverage privileges revoked and may be referred to collections. Members are responsible for all outstanding balances, collection costs, and attorney fees. A 10% non-refundable late fee will be added to any unpaid balance remaining after the start of the next billing cycle. All past-due balances and fees must be paid in full before membership privileges are reinstated.

Food and Beverage Billing

Annual Food and Beverage Obligations are in effect from November 1st through August 31st of each membership year. For the 2026-2027 membership year, the annual obligation is \$700 for Single, Intermediate Plus, and Intermediate Membership categories and \$1,100 for the Family Membership category.

No Food and Beverage Obligations apply to Junior Plus or Junior Membership categories. Any portion of the annual Food and Beverage Obligation not satisfied by August 31st will be charged to the Member's Golf Account at the conclusion of the Food and Beverage period.

Bag Storage and Locker

Members may be provided with bag storage and/or locker facilities at their request and solely at the Member's risk. Allendale Country Club ("ACC") assumes no responsibility or liability for the loss, theft, or damage of any personal property stored on Club premises, including but not limited to golf clubs, equipment, bags, clothing, or other personal items.

Bag storage and locker access are available only during posted Bag Room operating hours. Members should not expect access to stored items outside of these hours. If the Bag Room is closed, Members are responsible for taking their clubs and personal belongings with them.

ACC reserves the right to modify Bag Room hours, storage policies, and locker assignments at any time. Members must comply with all posted Bag Room rules and procedures.

All lockers must be cleaned out and all golf bags and personal property removed from ACC premises by November 15 of each year, unless otherwise determined by the Board of Directors. Any items remaining after the designated removal date may be removed by ACC at its discretion.

Golf Cart Privileges

Operators of golf carts must be at least 18 years of age and have a valid driver's license. (Proof may be required) Golf carts are not to be used by more than two riders and two golf bags at one time. Operators must abide by all directional signs when operating a golf cart. Please make note of the cart path conditions before playing. Any damage to any golf cart will be the financial responsibility of the operator and agree to pay for all damages sustained while said cart is in my possession or in the possession of family members or guests.

If applicable, to use a handicap flag, a member or guest must have a handicap placard or documentation and follow our handicap flag guidelines.

Extenuating Circumstances

Upon written correspondence directed to all Board of Directors, membership pauses, financial hardships and credits will be reviewed on a case-by-case basis by the board and shall be decided upon in accordance with the bylaws of the board of directors.

Rules Related to Member and Guest Conduct

Each Member agrees to abide by all rules and regulations established by Management related to conduct. These rules may include, without limitations, rules regarding conduct injurious to the operation of the Club, the reputation of the Club and/or Club Members, non-payment of fees and/or charges in accordance with the Club's terms, dress code, and golf etiquette. All Members and their guests are expected to adhere to proper conduct, including, but not limited to: repairing ball marks and divots on the course; refraining from using abusive language; no harassment of staff members or other Club guests; no violent behavior, such as club-throwing and interpersonal confrontations; compliance with stated cart rules; as well as acting in respectfully and with reasonable care for golf course property and equipment. In addition, any Member choosing to disregard Club hours of business, including, but not limited to the closure of the facility on holidays or rain days, will result in automatic forfeiture of the remaining Membership privileges without negotiation or compensation. Violations of any of the above rules or Club policies may result in the Club's right to cancel or revoke a member's benefits for a specified time or permanently at Management's discretion without negotiation or compensation.
